Informed Consent

Special Circumstances Due to COVID-19 Pandemic

Agreement to begin a custody and/or parenting time evaluation
or other clinical social work services with:
Lori A. Bonnevier, LCSW, LLC

The Oregon Shelter in Place Executive Order, resulting from the COVID-19 Pandemic, caused Lori A. Bonnevier, LCSW, LLC to take all client meetings online. As we move beyond the governor's initial order, precautions are being taken to ensure the best health for all families receiving services. Meeting on a virtual online platform is one way we can take care of each other so the world can begin to heal and restore itself from the total impact of Coronavirus. In an effort to continue serving children and families during this unique and ever-changing time, an online meeting platform will remain in place until further notice from Lori A. Bonnevier, LCSW, LLC. Meeting online has proven beneficial for families, and has not negatively impacted the delivery of services.

Simple Practice is a secure, HIPPA compliant, user-friendly, online platform where we will safely meet for all adult meetings and home visits.

This is an inimitable time and establishing virtual practice policies is a work in progress. Therefore, this agreement may be amended to include additional considerations as leaders in the field of family law continue to meet and discuss new ideas and best practices. Any future amendment will be communicated immediately, and in writing. Should you wish to cease meeting virtually at any time, please provide written notice to Lori A. Rules Regarding Online Meetings:

1. The evaluator agrees to provide clear and simple login information for meetings.
2. You agree to select a location for meetings that provides adequately for your privacy and a quiet atmosphere free from interruption and other persons.
3. We agree there is a WIFI network or data cellular connection available.
4. We agree there is a computer, laptop, cellular device, or tablet available.
5. If we are scheduled for an adult discussion (individual parent meeting), you agree your children **will not** be privy to the session. It is best if children are not anywhere within the same residence while an online virtual meeting is occurring. We will work together and schedule accordingly to ensure children are protected from adult conversation that could be harmful to hear.
6. The evaluator and parent agree not to record (voice or video) any portion of any online session in connection with a custody and/or parenting time evaluation.

A child custody and/or parenting time evaluation cannot be completed/delivered until Lori A. Bonnevier, MSW, LCSW has had an opportunity to meet with all parties (adults and children) one time, in-person. Office meetings are only being scheduled to complete the parent-child interaction. Infection control will be a priority in my office. Infection control processes are made so that when you and your children are visiting my office, it's both safe and comfortable. Below are infection control procedures Lori A. Bonnevier, LCSW, LLC will be following to keep all family members and office staff safe. The following procedures are offered by the U.S. Centers for Disease Control and Prevention (CDC). My office will continue to follow the advice of the CDC and remain up to date.

Here is what you can expect when arrive to the office with your children:

- Please call from your vehicle before walking up to the suite. Screening questions will be asked. If you or your child's temperature is above 99.6F, if you are sick or have been sick in the previous two weeks, have an active cough or experienced a cough within the past two weeks, please stay home. We'll reschedule, and we'll still get through the process.
- Please wear a face mask into the office for your appointment. If you do not have one, a clean, disposable mask will be provided for you. It is your parenting decision if you want your child to wear a mask during the meeting or not.
- Hand sanitizer is available by the door. Please use it for yourself and your children when entering the office. You will also find bottles of hand sanitizer throughout the space for your use as needed.
- Toys in the playroom are limited to those easily sanitized between appointments. Your child will receive a bag of activities for the visit that you make take home when we are finished. You are welcome to bring games and activities from home – the playroom will be freshly sanitized before each meeting.
- Appointments will be managed to allow for social distancing between families. That might mean that you are offered fewer options for scheduling your appointment. Only one family meeting will be scheduled in the office, per day. You will arrive to a freshly sanitized space that no other family has been in since, at a minimum, the day prior.
- An air purifying system is continually running in the meeting space.

Informed Assent

With my signature below, I understand that this Informed Consent Agreement is supplemental to the Disclosure Agreement that I signed for the child custody evaluation and/or other clinical services rendered by Lori A. Bonnevier, MSW, LCSW. I agree with the terms herein and agree to proceed with the court ordered evaluation or other clinical services using the virtual online platform, Simple Practice, and according to all the terms of this informed consent agreement. I understand that one face-to-face meeting with all parties (parents and child/children) is necessary before an evaluation can be completed.

With my signature below, I acknowledge receipt of the Simple Practice “Getting Started Guide.” Simple Practice is the Telehealth online platform that will be used for adult meetings, home visits, and other clinical services rendered by Lori A. Bonnevier, MSW, LCSW until a time when Lori A Bonnevier, LCSW, LLC determines (per the executive orders and other guidance of local, state, and national authorities) advises otherwise.

I understand my right for an attorney to review this informed consent agreement prior to signing below, which is highly recommended by Lori A. Bonnevier, MSW, LCSW.

By virtue of my signature below, I acknowledge that I have read and understand all the terms within this informed consent agreement and that I am agreeing to be bound by the Rules Regarding Online Meetings. I understand that Lori A. Bonnevier, MSW, LCSW, is an independent practitioner and that this contract is only with her and not with any other entity or individual.
